Background / Current Situation

On March 16, 2020 the Vermont State Emergency Operations Center (SEOC) was partially activated from 0800 to 1600. Starting tomorrow, the SEOC will be transitioning to a hybrid EOC structure (physical/virtual) with limited in-person staffing at Public Safety Headquarters and State partner representatives working remotely from 0800 to 1600 going forward.

Key Updates from 3/16/20:

- Burlington has declared a State of Emergency, bars will be closed and restaurants will only be serving take-out.
- Governor Phil Scott has ordered the dismissal of all schools in Vermont and the cancellation of all school related activities by no later than Wednesday, 3/18/20. The Agency of Human Services (AHS) is working with the Agency of Education (AOE) to create guidance for childcare facilities.
- Gov. Phil Scott amended his emergency declaration to limit public gatherings to either 50 people or 50% occupancy, whichever is less. This was based on guidance from the Center for Disease Control (CDC) to cancel all public gatherings of over 50 people for the next 8 weeks.
- Wednesday, 3/18/20 will be the first of a weekly call with law enforcement, fire service, emergency medical services, and medical examiners to provide an overview of the State's response to COVID-19 and to answer questions.
- The Center for Disease Control (CDC) is now allowing state labs testing results to be assumed positive without CDC verification.
- All 50 states have now declared a State of Emergency.

The Federal Emergency Management Agency (FEMA) Region 1 Regional Response Coordination Center (RRCC) activated on March 16 to a partial activation in Maynard, MA to coordinate requests for federal resources and capabilities across the six New England States.

- FEMA Stafford Act declaration FEMA-3437-EM issued March 13, 2020 for the State of Vermont
- Reimbursement for emergency protective measures such as the activation of State Emergency Operations Centers, National Guard costs, law enforcement and other measures necessary to protect public health and safety.
- Does NOT duplicate assistance available through the Public Health Emergency

Public Information

- Inquired with the Vermont Department of Health about guidance for an upcoming outdoor dairy auction a recommendation has been made to cancel.
- Advised Department of Labor / Agency of Commerce and Community Development (ACCD) on H-2A Visa changes at Jamaican embassy impacting possible immigrant workers in Vermont and beyond.
- Advised Vermont National Guard about fake texts advising people to stock up because a national lock down was imminent and military would be called out to enforce.
- Posted Governor's press conference live to Vermont Emergency Management facebook page.
- Posted Agency of Commerce and Community Development (ACCD) business awareness post to Vermont Emergency Management facebook page.
- A press release was drafted for Governor's Office and Health on updated gathering guidance associated with the Executive Order.
- Discussed volunteer and donation messaging story with VTDigger inquired if they had vetted all links to donation and volunteer sites.

External Resources Unit

Vermont Department of Health placed a Health External Resource Request:

- EMAC submitted to request healthcare providers who are licensed, certified, or registered in [NH, MA, NY] to practice in Vermont so they may care for Vermont patients via telemedicine services. Such services shall be limited to triage, diagnosis or treatment directly related to identifying or treating a patient for COVID-19.
- Working with Agency of Human Services (AHS) on a potential EMAC need for correction officers.

Resource and Capabilities Unit

The Resources and Capabilities Unit's agencies have been focused on coordinating information requirements and continuity of operations plans with Law Enforcement, Fire Service, and Emergency Medical Services, and coordinating support for the Department of Health lab.

- MARS is working with the Department of Health (VDH) for assistance from other state agencies to provide lab technicians to assist in Health Lab.
- MARS is working with SerVermont to provide Volunteers to VT 211, Health Department call center and Strategic National Stockpile warehouse.
- MARS is working with Vermont State Police (VSP) and other state agencies to deliver Strategic National Stockpile supplies on Tuesday and Thursday.

Vermont Department of Health

HOC Public Information Officer:

- Over 47,000 visits to the web on Sunday, March 15.
- Vermont Department of Health (VDH) Website reflects latest guidance in the process of updating school guidance.
- HANs sent out today: Conservation of Personal Protective Equipment (PPE) Friday evening; Lab testing procedures on Saturday.
- Media:
 - Press release to go out after Governor's press release which will capture the four new positive cases from yesterday.
 - Working on additional press release around contract tracing for people who visited a specific establishment.
 - Media requests asking for test numbers run by date.
 - Media asking about drive through/pop-up sites.
 - Seven Days VT working on restaurant week (April) adaptation. Working on how to message in support of food workers.
 - Continue to successfully coordinate with hospitals to announce cases.
- Staff have been in contact regarding SEOC taking over communication with 211 and daily e-mail updates to state employees. SEOC taking lead on Governor press conferences and executive orders.

HOC Operations:

- University of Vermont Medical Center (UVMMC) is standing up internal facing provider hotline
- Vermont Child Health Improvement Program (VCHIP) is distilling HANs and sharing with primary care networks.
- Working to establish testing centers outside of hospitals. Creating a plan to release if/when decision is made to implement.
 - Commercial labs will be on board this week symptomatic testing can also go to them.
- Epi:
 - Cases showing more widespread activity in communities:
 - Seeing more cases in their 30s
 - Increase in activity among out of state residents leaving larger urban areas
 - Healthcare contact investigations at least 130 identified as exposed, especially at the Veterans Affairs Hospital. There is an immediate contact tracing need.
- Health Communications Director:
 - Passed along 1135 CMS waiver to Department of Disabilities, Aging, and Independent Living (DAIL) if needed, for altered standards of care.
 - Compiling resource requests 108 requests for PPE and healthcare supplies
 - Epi has assigned someone to work with UVMMC on an ongoing basis.

- Healthcare supply email will be removed from website. Directing resource requests to survey gizmo link and call center.
- Office of Local Health: Women, Infants, and Children (WIC) program applied for a federal waiver to extend food packages for 30 days and working to implementing teleWIC.
- School Branch: Closure guidance going up on website. Mostly getting calls about specific circumstances on Monday/Tuesday. Have sent childcare guidance to DCF for edits.
- Office of Chief Medical Examiner:
 - Investigators are scheduled to be fit tested should be complete by the end of a week
 - Plan to work with response partners on communication/clarification at death scenes (law enforcement, fire, states attorney, etc.)

HOC Logistics: Strategic National Stockpile shipment should arrive. Will prioritize requests that have already come in.

HOC Planning:

- Guidance on social distancing within HOC and virtual HOC by the end of the day
- Request for command staff and chiefs to identify at least 2 backups for positions by end of week
- Filling requested positions/scheduling (including increased need for health care-associated contact tracing)

Agency of Education

- The Governor has directed that all schools dismiss by the end of day on Tuesday, March 17, 2020.

Agency of Human Services

• Secretary's Office is working on an all Agency of Human Services (AHS) email with common

Q&A that may help reduce questions and calls.

- Department for Children and Families (DCF):
 - Centers for Disease Control (CDC) is developing a guidance document in coordination
 with Vermont Department of Health (VDH) that recommends private childcare programs
 remain open, with consideration of the size of program and social distancing, and around
 informal care (where an older family member cares for a younger family member). We are
 also developing guidance on education fund payments that are made to private childcare
 programs, coordination with the Agency of Education (AOE).
 - Establishing a tracking system to keep running numbers on program closures and impacts on programs. We are ensuring continuity of financial support with respect to state-controlled funding.
 - DCF, working with Vermont Department of Health (VDH), responded to a media inquiry from the Burlington Free Press.
 - Mobilized Community Homeless Response Teams at the local level to liaison and coordinate with state efforts.
 - Guidance to Homeless Shelter Providers are currently under VDH review.
 - Implement General Assistance Hotel Voucher Motel Access Statewide
 - Mobilize resources needed to stand up congregate recovery centers by the end of the week in highest need areas. (Likely in order: Burlington, Barre, Brattleboro, and Rutland). May require assistance from the National Guard.
 - Reguest for Medical Reserve Corps and Americorps support.
- Department of Corrections (DOC): looking for possible staffing support for correctional facilities.
- Department of Mental Health (DMH): developing documents on how Vermonters can access behavioral health services should they be needed.
- Disabilities, Aging and Independent Living (DAIL):
 - Looking to fulfill a call center staffing request from the Health Operations Center (HOC).
 - Working to identify potential future gaps and available resources for home delivered meals for homebound older and disabled Vermonters for the duration of this incident.
 - Working to deliver guidance to network partners regarding ordering of supplies.
 - Working on providing guidance outlining temporary suspension of certain requirements.
 - Messaging to partners regarding the closure of congregate day sites.

Agency of Commerce & Community Development

- Connected with Vermont Grocers Association today:
 - Shaw's, Price Chopper, and Hannaford have entered allocation agreements, not to increase orders.
 - Smaller stores are now being depleted as larger stores sell out. Dollar Stores are not members, so no information on their supply chain. Convenience stores are offering to be sites for drive in testing.
 - Industry stress points:
 - Women, Infants, and Children (WIC)/Supplemental Nutrition Assistance Program (SNAP) regulations to keep certain items stocked.
 - Agency of Transportation full trucks getting to stores may be over local road weight limits.
 - Bottle Redemption ability to suspend operations, Agency of Natural Resources (ANR) is on board.
 - Looking for guidance on not allowing reusable bags.
 - In demand items seeing shortages: toilet paper, canned goods, cleaners, sanitizers, cereal, pasta, chicken and beef.

- Agency of Commerce and Community Development (ACCD)/Small Business Administration (SBA) Loans:
 - Dedicated email account that launched Friday saw more than 150 businesses contact ACCD over the weekend looking for support.
 - ACCD is currently going through emails and having businesses fill out declaration forms.
 - SBA Loan Submission will hopefully on 3/17/20
- Essential Elements of Information/Areas of Concern:
 - There is growing concern and calls for more aggressive guidance from ACCD, VEM, Governor on what non-essential retail and service sector businesses should be doing. White River Junction is circulating a petition. The business community is looking for direction.
- Reminder that all business inquiries can be driven to commerce.covid19@vermont.gov, ACCD
 has set up a team to ensure all inquiries coming through that email are addressed.
- ACCD convened a group of of business leaders and organizations today to make sure coordination, work flow, and community support are all working in tandem. Participants included: VEDA/RDCs/SBA/SBDC/ACCD/Labor. The group will continue to connect multiple times a week.
- Department of Housing and Community Development (DHCD) is convening the VT Housing Council via Conf. call tomorrow 3/17/20 at 1pm:
 - To assess the needs of tenants and property owners (both within our network and generally) in response to the pandemic
 - To discuss any potential emergency administrative actions requested
 - To discuss suggestions for legislative responses
 - To establishing ongoing communication channels
- DHCD is participating in a conference call with US Department of Housing & Urban Development (HUD) to discuss using existing Vermont Community Development Block Grant (CDBG) funding to support COVID-19 recovery needs.
- DHCD is working on a communication plan for Municipal Planners, Downtown organizations and other seeking information.

Vermont State Police

- Potential deployed assets:
 - The Vermont Department of Health (VDH) lab asked all state agencies if they had microbiologists on staff that were available to assist in the lab. VSP is working to identify potential personnel that are qualified and/or able to assist. Fish and Game does not have anyone who could assist with this need.
- Pending missions:
 - The Vermont Department of Health (VDH) requested VSP assist with the delivery of Personal Protective Equipment (PPE) currently being stored in their warehouse in Colchester, VT to area hospitals, medical centers and fire departments around the state. VSP is currently working with state agency partners and VDH to accomplish this mission. The VDH advised the orders will be ready to be delivered on Wednesday.
- Potential resource needs:
 - The VSP requested appropriate PPE for our Troopers through the VDH online survey monkey.
- Security & Crime Issues: none

Division of Fire Safety

- Urban Search and Rescue (USAR) will be assisting Vermont State Police (VSP) with moving the Strategic National Stockpile supply reserve.
- A Survey Monkey has been developed by the Vermont Fire Academy to go out to all the county fire
 - mutual aids in the state to check on manpower and any gaps in resources.
- Status of fires and/or affected buildings/structures: None
- Sites requiring life safety debris removal and emergency access issues: None
- Requested inspections of damaged structures: None

SerVermont

- SerVermont continues to work with AmeriCorps members and Medical Reserve Corps Volunteers to fill rosters for volunteer requests.
- Current Requests: Vermont Department of Health (VDH) Call Center (this week) and 211 Call Center. 211 Call Center would like to move up the volunteer start date from March 23 to this week.
- SerVermont is designing a database to collect offers from volunteers and requests for services.
 We will track these offers but do not want to encourage folks to reach out in this way. Our message to volunteers is that we do not currently have any formal opportunities for volunteers and encourage them to reach out to local communities and affiliate with an ongoing volunteer effort or organization.
- SerVermont is still seeking guidance on how to best prioritize volunteer resources given the
 limited number of volunteers in our pool and the increase in requests. If either call center
 transitions to a remote setting we will likely be able to provide more coverage. We are also
 seeking health guidance to provide with volunteers to ensure that we are not making requests that
 jeopardize anyone's safety.

Military Support

- Non-state (EMAC, IEMAC, federal) resource status: No EMAC resources at this time. National
 All-Hazards Coordination Workshop, originally scheduled to start today in New Orleans, was
 cancelled. This annual event includes representation from the fifty states and four territories and
 serves as the major coordination opportunity for EMAC resources short of actual requests.
- Deployed special state assets: None at this time
- Pending missions: No resource requests from any State partners.
 - One Air National Guard planning officer on 5-day Annual Training orders.
 - One Army National Guard planning officer on 14-day Annual Training orders.
 - Pending mission is actual request from State Partner, received and verified by the Director of Military Support and sent to the VT National Guard for actual unit sourcing.






Jurisdictions with COVID-19 declarations, proclamations, orders, etc. (March 16, 2020)


